The Committee discussed the agenda in details resolved the following:

Resolved that an e-resource centre exclusively for ODL and Online programmes may be considered. And the suggestion of the Controller of Examinations and Librarian of the University to utilize the e-resources of the University Library for this purpose may be considered.

8. To permit the Centre for Distance & Online Education to start Interactive radio counseling through Social media.

Resolved that starting of the Interactive raidio counseling through Social Media may be considered in future.

9. To provide digitalized SLM for the Learners.

Resolved that providing the digitalized SLM for the Learners be considered and necessary action may be initiated.
