ELECTION TO THE SYNDICATE:

Class II – Other Members – Sub-Sec. (b) (2) of Section 24 under Chapter IV of the Bharathidasan University Act, 1981 - Two Members elected by Teachers of Affiliated Colleges, other than Principals, from among themselves who are members of the senate, in accordance with the system of proportional representation by means of the single transferable vote.

FILLING OF CASUAL VACANCY:

Section 47 under Chapter X of Bharathidasan University Act, 1981 (Tamil Nadu Act 2 of 1982).

The total number of vacancy in the Syndicate are Two (Residual Vacancy).

The tenure of office is upto 26.01.2027 from the date of declaration of the result of the election.

In this connection, nominations are invited in the prescribed format which can be obtained from the Registrar (FAC) and Returning Officer on requisition and on submission of **Demand Draft for Rs.590/- (Including GST – Five Hundred and Ninety only) drawn in favour of Bharathidasan University, Tiruchirappalli on or after the date of notification viz. 22.10.2025** with stamped self-addressed envelope to the value of Rs.26/- (Rupees Twenty Six Only) or in person.

Nomination papers shall be enclosed in an envelope superscribed as follows, as the case may be

“NOMINATION FOR ELECTION TO THE SYNDICATE – BY THE TEACHERS OF THE AFFILIATED COLLEGES OTHER THAN PRINCIPALS FROM AMONG THEMSELVES WHO ARE THE MEMBERS OF THE SENATE”

The Members are requested to send the nomination by Speed Post with (Acknowledgement Due) so as to reach the Registrar (FAC) and Returning Officer within the date and hour fixed or delivered to the Registrar and Returning Officer either in person or by messenger within the date and hour fixed.

Nomination papers that are not being sent as stated above shall be declared invalid.

INSTRUCTIONS

1. The Election is conducted in accordance with the System of proportional representation by means of single transferable vote i.e., vote by placing the figure "1" in the space opposite the name of the candidate for whom you to vote as First choice. The figure "2" in the space opposite the name of candidate who is your second choice and "3" for the Third choice and so on. Crosses or other marks must not be used.
2. If the figure "1" is not marked, or figure "1" is set opposite the names of more than one candidate, or figure "1" and some other figure are set opposite the names of the same candidate, the ballot paper will not be taken into account for counting.
3. The total number of vacancy is as follows:
 - a) Two members to be elected to the Syndicate by the Teachers of the Affiliated Colleges other than Principals from among themselves who are members of the Senate
4. The total number of vacancy are two in the Syndicate and the tenure of office will be upto 26.01.2027 from the date of declaration of the result of the election.
5. Nomination papers should be enclosed in an envelope super-scribed as follows:

**"NOMINATION FOR ELECTION TO THE SYNDICATE BY
THE TEACHERS OF AFFILIATED COLLEGES OTHER THAN
PRINCIPALS FROM AMONG THEMSELVES WHO ARE
MEMBERS OF THE SENATE"**
6. Nomination should be sent by "Speed Post with Acknowledgement Due" so as to reach the Registrar (FAC) and Returning Officer during the Office hours either in person or by messenger within the date and hour fixed.
7. Nomination paper/s that are NOT enclosed in an envelope superscribed as specified and sent by 'Speed post with acknowledgement due' or are not delivered in person or by messenger as required above shall be declared invalid.
8. No person shall be present at that scrutiny except the Returning Officer and such staff who are assigned to assist the Returning Officer. The candidates and or not more than one representative of each candidate appointed in writing may be present during scrutiny.

9. An elector shall be eligible to subscribe either as proposer or as seconder in Nomination papers only as many times as there are vacancies but not more.
10. A ballot paper will be invalid

(a) Which does not bear the signature/facsimile of the Returning Officer.

or

(b) On which a voter signs his/her name or writes any word or makes any mark, by which it becomes recognizable.

or

(c) On which the figure 1 is not marked

or

(d) On which the figure 1 is set opposite the names of more than one candidate

or

(e) On which the figure 1 and some other figure are set opposite the names of the same candidate

or

(f) If it is void for uncertainty
