# Course Name: Objects and Commodities

#### **Overview:**

The study of objects through material culture provides unique insight into people and society. The meaning of the objects can critically be decoded only in relation to their creators as well as the social and historical conditions within which the objects have been produced. Hence objects have social significance as they reflect the history of the culture in which they are produced. Whereas commodity is a useful external object produced for exchange in a market. Hence the existence of market and social division of labour form the necessary condition for commodity production. This simple process gets complicated when the ideology behind exchange value is politicized. The predetermined ideologies obtain social control through illusion and manipulation that leads to the maintenance of social hierarchy and consent of order and acceptance of the products. In other words, capitalism manipulates the consumers and consumption as means to craft personal self and identity in a globalized world. The commodity and the entities related through commodity play a vital role in the social reproduction of class and gender division. The need and desire of the consumer along with production and circulation determines the value of the product. The conformity of the consumers creates commodity fetishism which is deliberated through aesthetic ideals. Habermas rightly stated this process where the rational citizens become non-rational consumers. The structure of authority is established when a commodity is standardized by reinforcing the power to construct capitalistic ideologies. To put together, commodification and consumer culture have intimate relationship between large scale economic systems, particularly market capitalism and hegemonic cultural ideologies. In contemporary context every entity is being commodified starting from food, clothes, shelter, water, environment, disease, tradition and above all women - through objectification. Within this premise this course on "Objects and Commodities" will highlight on the theoretical aspects of cultural fetishism and its relevance in decoding contemporary literary and popular culture.
