CURRICULAM CERTIFICATE COURSE ON FIRST AID AND SAFETY MANAGEMENT REGULATION

1. Eligibility

I. For Admission : A pass in the Higher secondary Examination (Academic /Vocational stream) conducted by the Government of Tamil Nadu ; or an examination accepted as equipment thereto by the syndicate ,subject to such conditions as may be prescribed thereof.

II. The age of the candidate should be 18 years completed.

2. Duration

The course is for a period of one semester /six months/150 hrs.

3. Course of study:

Candidates shall be permitted to do this certificate course on first aid and safety management concurrently with their UG/PG degree programme including programme under Distance education mode. The classes may be conducted either during week days after class hours or during weekly holidays. The candidates undergoing various course in the university Departments of Bharathidasan University particularly the students of M.A (HRM) of the Department of lifelong learning are permitted to do this certificate course on First Aid and Safety Management concurrently with their PG programme.

4.Scheme of Examination.

Note : practical /field experience or training shall also be conducted in the relevant areas.

5. Distribution of Teaching hours

There shall be a total number of 150 actual contact hours. Each paper shall have 50 hours.

6. Examination:

a. There shall be examination at the end of the course i.e. December / January/February or June/ July /August. A candidate who does not pass the examination in any subject(s) shall be

permitted to appear in such subject(s) in the subsequent examination. All the candidates shall be required to register for the entire examination at the first appearance.

b. The results of all examinations will be published at the Department in which they took the examinations.

7. Passing Minimum :

A candidate shall be declared to have passed in each paper if he /she secures not less than 40% of the prescribed maximum marks. He /She shall be declared to have passed the whole examination and qualified for the certificate, if He /She pass in the papers.

8. Classification of successful candidates

Those who secure 60% or above the maximum shall be declared to have passed in I class; those who secure 50% or above but below 60% shall be declared to have passed in II class. All other successful candidates shall be declared to have passed the examination in the III class.

9. Award of certificate

A candidate shall be eligible for the award of the certificate if He /She has passed all the examination prescribed thereof.

10. Revision of Regulations and curriculum.

The University may from time to time revise, amend and change the regulation and the curriculum it found necessary.

Unit – 1

Human Body System and functions, Basic principles and guidelines to the first aides – Rules and Scope of First Aid – Attitude problem of First Aid – Action at an emergency and life threatening conditions. Fundamental of First Aid.

Unit -2

Cardiac and respiratory emergencies and CPR – Hypoxia and suffocation – shock and unconsciousness Fainting –Head and spine injuries during clash and blast – the Burns –Wounds and sever bleeding –injuries and fracture-Dressing and Bandages, Recovery positions. Fire extinguish – gas, minerals, oils, electricity in houses, industries /offices .Heat and Cold emergencies.
