F.SRO/NCTE/SRCAPP201630004/M.P.Ed./2020/118183-8189 dt. 16.09.2020 for conducting M.P.Ed. programme 40 students (one unit) from the academic session 2021-2022.

- AND WHEREAS, the SRC in its 430th Meeting held on 01st December, 2023 considered the matter and decided to issue a letter to the institution. Accordingly, as per the decision of SRC a letter was issued to the University on 15.12.2023. The University has submitted the reply vide letter dt. 08.01.2024.
- AND WHEREAS, the SRC in its 433rd Meeting held on 10th February, 2024 has 3. considered the matter and decided as under: -

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Bharathidasan University, Tiruchirapalli, Plot No.623, 616, NH-210, Pudukottai Road, Suriyur Village, Bharathidasan university Post, Thiruvarumbur Taluk, Toruchirapalli City and District-620024, TamilNadu for M.P.Ed. programme 1 basic unit of 40 students.

- NOW THEREFORE, this order is issued permitting the institution i.e., Bharathidasan University, Tiruchirapalli, Plot No. 623, 616, NH-210, Pudukottai Road, Surivur Village, Bharathidasan university Post, Thiruvarumbur Taluk, Toruchirapalli City and District-620024, TamilNadu for Continuation of recognition for M.P.Ed. programme of two years duration with an annual intake of 1 basic unit of 40 students subject to fulfilment of the following conditions: -
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint I. account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - The institution shall be free to post additional relevant information if it so desires.
 - Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
